

Pro Velo Super League – Website Terms of Use

By using the website <u>www.provelosuperleague.com</u> (*Website*), you agree to indemnify Provelo Super League Pty Ltd as trustee for The Provelo Super League Unit Trust (ABN 26 376 926 622) (*PSL*, *us* or *we*), and its officers, employees and agents from and against all actions, claims, suits, demands, damages, liabilities, costs or expenses whether direct or indirect (arising out of or in any way connected to your use of our Website).

1. Agreement to the Terms of Use
